1. QUALIFYING REQUIREMENTS

The Tenderers / Firms meeting the following conditions need only apply.

1.1 CONSTITUTION OF BIDDER/ TENDERER

- Registered firm can only participate. Consortiums of Firms are not eligible.
- Registration Certificate of the Tenderer shall invariably be furnished.

1.2 TECHNICAL REQUIREMENTS


- The Tenderer should have completed satisfactorily at least one similar Job of 33KV or higher voltage on turn key basis in the last 5(five) years in the North-East region as on the date of bid opening and which must be in satisfactory operation as on the date of bid opening.
- Certified copies of the documentary evidence of their past experience for successful completion of the similar works from the clients (by an officer not less than the rank of an Superintending Engineer) shall be furnished.
- The list of turn Key Jobs of similar/higher rated capacity completed prior to the opening of this Tender for the last 5(five) years shall be furnished.
- Decision of the Government will be final.

1.3 COMMERCIAL & FINANCIAL REQUIREMENTS:-

- Average Annual Financial turnover during the last 3(three) years should not be less than Rs. 15.00(fifteen) crores. Certified balance sheet along with Chartered Accountants certificate indicating the turnover has to be attached with the Bid

1.4 SUBMISSION OF DOCUMENTS FOR ISSUE OF TENDER PAPERS:

- a) The Tenderer should furnish documentary evidence in support of the qualifying requirement stipulated as above.
- b) The Tenderer, who wish to tender for the works, may submit their application request for issuing Tender Papers / Bidding Documents to the **Chief Engineer (Power), Electricity Department, Government of Manipur, Keishampat Electricity Complex, Imphal-795001** on or before the specified date.
- c) The application request along with the enclosures shall be submitted in a sealed envelope, which shall be super scribed "**REQUEST FOR TENDER PAPER, MANIPUR**" along with the Cost of the Tender paper (Non-refundable) shown above, in the form of Demand Draft from a Nationalized/Scheduled Bank preferably having its branch at Imphal (preferably State Bank of India), drawn in favour of the **Executive Engineer, Sub-Station Construction Division No. -II, Electricity Department, Manipur**. Application without cost of the Tender paper shall not be considered.
- d) Tender paper containing detailed Specification of the works along with Terms & Conditions will be issued to the qualified intending Tenderers/Firms based on above criteria duly scrutinized by a Committee constituted by the Department.
- e) The cost of Tender Papers / Bidding Documents shall be non-refundable. A self addressed envelope (cotton linen lined) of suitable size with sufficient stamp for sending the tender papers by SPEED POST or by REGISTERED POST for the areas not covered by Speed Post should also be accompanied with the application for purchase of Tender Papers / Bidding Documents.
- f) Any delay / loss / non-receipt of the application for purchase of Tender Papers / Bidding Documents or of the Tender Papers/ Bidding Documents sold / issued or also in submission of completed Tenders due to Postal delay or any other reasons not attributable to the Department shall not be the responsibility of the Department and no time extension on these grounds shall be entertained.
- g) The Department is not bound to accept the lowest tender / bid and reserves the right to reject any or all the Tenders or to accept any Tender in full or part thereof, without assigning any reason, whatsoever. The last date of sale / issue of Tender Paper and also the last date of receipt of Tender and DUE DATE for opening Tender happens to be a holiday, the same shall be on the next working day at the same time.
- h) Finalisation of the Tender shall be subject to sanction of Projects by Ministry of DoNER.
